

Envision Credit Union – “Swipe, Sign and Win”

1. Sweepstakes Administration

This sweepstakes is being administered and operated by Envision Credit Union a (Sponsor).

2. How to Enter

Registration for the “Swipe, Sign and Win” will take place on January 1, 2017 thru December 31, 2017. Members who use their VISA debit card at least 25 times per month (by swiping and signing for transactions) during each month of the registration period will be entered into the giveaway for that month. Each member may be entered to win a maximum of 1 time for each month in the contest period. No purchase is necessary to enter, nor will a purchase increase your chances of winning. You do not need to fill out any additional forms, nor will any additional forms be sent to you. If you desire to enter the sweepstakes other than through registration of the Swipe, Sign and Win, print your name, address, and telephone number on a 3x5 card. Send the card to Envision Credit Union, “Swipe, Sign and Win 2017”, 440 N. Monroe Street, Tallahassee, FL 32301. One entry per person per month per contest period. Entry must be postmarked by the 28th of each month for that month’s entry. Entries will not be acknowledged or returned. Neither the sponsor, Envision Credit Union, nor any affiliates, partners, employees, officers or directors of either shall be responsible for lost, misdirected, incomplete, or illegible entries.

3. Sweepstakes Period

The sweepstakes period runs from 12:00 AM ET on January 1, 2017 until 11:59 PM ET on December 31, 2017.

4. Eligibility

The contest will be open only to natural born persons or permanent and lawful residents of the United States of America, and eighteen (18) years of age or older and must not be considered a minor in your state of residence at the time of entry. The following persons are not eligible to enter the contest: (a) Employees of the sponsor, Envision Credit Union, and their subsidiaries and affiliates, and (b) any immediate family members of any such employee, whether living in the same household or not, and (c) anyone living in the same household, whether related or not. The term "immediate family" includes spouses, siblings, parents, children, grandparents, and grandchildren, whether as "in-laws," or by current or past marriage(s), remarriage(s), adoption, co-habitation or other family extension.

5. Prizes

One winner for each month in 2017 of the Swipe, Sign and Win contest will receive a \$100 VISA gift card. This VISA gift card is non-transferable and cannot be exchange for any other monetary prize. See Prepaid VISA gift card details at www.EnvisionCU.com.

Prize drawing for each month will occur during the next business week following the end of the month. The winner will be selected at random from all entries. The odds of being a contest period winner depend on the total number of eligible entries received.

The winning entries will be represented by a VISA debit card number. Winners will be notified and awarded by Envision Credit Union. Exact prize components are subject to change without notice. If a non-eligible winner is chosen, the sponsor, Envision Credit Union, will select another winner.

The sponsor, Envision Credit Union, will select the prize winner. Federal, state and local tax

liability and any other expenses are the sole responsibility of the prize winner. Void where restricted and prohibited. Prize is non-transferable, non-assignable and non-exchangeable.
