

## Envision Credit Union – “eStatements Sweepstake”

### 1. **Sweepstakes Administration**

This sweepstakes is being administered and operated by Envision Credit Union a (Sponsor).

### 2. **How to enter**

Registration for the “eStatements Sweepstakes” will take place on October 1, 2019 thru November 30, 2019. Members who have enrolled in eStatements by the end of the sweepstakes period will automatically receive one (1) entry. No purchase is necessary to enter nor will a purchase increase your chances of winning. You do not need to fill out any additional forms, nor will any additional forms be sent to you. If you desire to enter the sweepstakes other than through registration of the eStatements Sweepstake, print your name, address, telephone number on a 3x5 card. Entries will not be acknowledged or returned. Neither the sponsor, Envision Credit Union, nor any affiliates, partners, employees, officers or directors of either shall be responsible for lost, misdirected, incomplete, or illegible entries.

### 3. **Sweepstakes Period**

The sweepstakes period runs from 12:00 AM ET on October 1, 2019 until 11:59 PM ET on November 30, 2019.

### 4. **Eligibility**
